If my exhibit is not self-propelled it will be covered by a Public Liability Policy and, in all cases, by a Boiler Explosion Policy. Both policies will have a limit of indemnity of not less than £5,000,000 in any one accident, and Sparks and Ashes cover for not less than £250,000.

2 I further declare that the boiler of any steam plant entered carries a current Boiler Inspection Certificate and that I will produce documentary evidence of such Insurance and Inspection to you before participating in the event.

3 I further declare that the driver(s) hold a driving licence of the appropriate class and will produce, if required, such a licence, and that the driver(s) have read the NTET Traction Engine Code of Practice.

4 I agree to produce, on request, an inspection certificate in accordance with the IEE Regulations for any electrical equipment (i.e., generators, wiring, appliances).

5 I agree to abide by the Code of Practice of the National Traction Engine Trust and the Society’s written Statement of Safety Policy

6 I agree to operate my exhibit during the Event and comply with the instructions of stewards.

7 In the event of any dispute the Event Organisers’ decision is final.

8 Unloading and moving of exhibits is to be done only in designated areas, and exhibits in place by 10.00 am.

9 **I agree not to move or remove my exhibit from the Showground after 10.00 a.m. or before 5 p.m. on either day, unless escorted under steward supervision.**
