Conditions of Entry:

1. There will be no movement of my vehicle on site during the show operating times (9.30 to 5.00) and I will be in place by 9.30am and will remain in place until 5pm, unless escorted under steward supervision. **This is a condition of entry.**

2. I agree to operate my exhibit during the event as requested; to ensure that anyone having care of the exhibit is fully conversant with its operation; to comply with the Code of Practice for the National Traction Engine Trust and the Gala's Safety Policy; and comply with the instructions of the stewards. In the event of a dispute the Event Organisers decision is final.

3. I declare that during the Event my exhibit will be covered by the minimum insurance requirements as required by the Road Traffic Act, if my exhibit is not excluded from use on the Public Highway, irrespective of whether it is licensed or not.

4. If my exhibit is not self-propelled it will be covered by a public liability policy having a limit of indemnity of not less than £2,000,000 in any one claim.

5. I further declare that the driver/rider of any exhibit is not excluded from use on the public highway and holds a full current driving license of the appropriate class for that exhibit.

6. I agree to produce the insurance and license documents for the Section Steward. The Event Organisers or Safety Officer can also request to see them if necessary. I agree to produce, on request, an inspection certificate in accordance with the IEE Regulations for any electrical equipment (i.e. generators, wiring and appliances).

7. Vehicles can only carry passengers where correct fixed seating is available.
